- A. The purpose of this addendum is to provide clarification to the Cone of Silence as denoted in Section 1.9 of the proposal:

**“Cone of Silence,” as used herein, means a prohibition on any communication regarding this Request for Proposal (“RFP”). Pursuant to Section 2-11.1(t) of the County Code, the Cone of Silence remains in effect until the Village Manager has made a written recommendation to Village Commission. During the Cone of Silence the following is prohibited: Any communication (oral or written) regarding this solicitation between a potential vendor, service provider, Proposer, lobbyist, or consultant and the Village Commission, evaluation committee members or the Village Manager and the Manager’s professional staff, unless permitted by one of exceptions.**

**Any written communications or inquiries, except for clarification of process or procedure already contained in the solicitation, are permitted provided the written communications are directed to Angela Atkinson, Chief Financial Officer, at [aatkinson@nbvillage.com](mailto:aatkinson@nbvillage.com). Such written inquiries or requests for information shall contain the requester’s name, address, and telephone number. If transmitted by facsimile, the request should also include a coversheet with Proposer’s facsimile number. The request may also be electronically sent to [aatkinson@nbvillage.com](mailto:aatkinson@nbvillage.com) or mailed to the Chief Financial Officer, 1666 Kennedy Causeway, Suite 300, North Bay Village, FL, 33141. Written communications to other Village officials or employees are prohibited until the Cone of Silence has been lifted.**

**This Addendum to the cone of silence and proposal is issued to provide additional information and clarification to the original proposal and is hereby declared a part of the original proposal and documents. In case of conflict, this Addendum shall govern.**

**All other terms and conditions of this RFP remain unchanged.**

**This Addendum shall be considered an integral part of the RFP and Contract Documents and this Addendum must be signed and returned with your submittal **by 2:00 p.m. on December 9, 2021**, and acknowledged on Form 5 Designated in Section 4. Failure to comply may result in disqualification of your bid submittal.**
