a. In the detail it states “used mostly on residential streets with speed limits up to 25 MPH” please confirm that this speed hump is the one to be used on this project.  
b. On the MUTCD the latest version of the Speed Humps installation guide recommends installing speed hump warning signs. (Attached)  
c. Based on this, can you please clarify if item #7 of Mechanical Speed Hump should we include the respective signs.
