RESOLUTION NO. 2020-081

A RESOLUTION OF THE COMMISSION OF NORTH BAY VILLAGE, FLORIDA, APPROVING A MODIFICATION OF THE VILLAGE CARES ACT-FUNDED, GIFT CARD PROGRAM TO BE USED PRESIDENTS SUPERMARKET FOR RESIDENTS IN NEED OF FINANCIAL ASSISTANCE FOR FOOD; AUTHORIZING THE VILLAGE MANAGER TO ENTER INTO AN AGREEMENT AND EXPEND PREVIOUSLY BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Commission of North Bay Village, Florida, adopted Resolution 2020-072 on November 23, 2020, which authorized the Village Manager to enter into an agreement with YIFTEE for a MasterCard™ program that would also provide financial assistance to North Bay Village residents in need due to the economic effects caused by COVID19; and

WHEREAS, the Village has been approved to be fully reimbursed by Miami-Dade County (the "County") for distributing direct Covid relief;

WHEREAS, subsequent to the approval of the program approved by Resolution 2020-072, the Village has determined that it is in the best interests of the Village, its residents, and its local businesses to use some of the previously approved funding for a food assistance program utilizing the sole grocer located in the Village, Presidente Supermarket #32; and

WHEREAS, adding the Presidente Supermarket #32 component does not change the previously approved amount of \$119,062.00 for assistance programs .

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR

AND COMMISSION OF NORTH BAY VILLAGE, AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

<u>Section 2.</u> <u>Approval.</u> A modification of the Village's Cares Act-funded gift card program, authorizing the use of previously-approved funding for use as financial assistance for the purchasing of food at the Village's sole grocer, Presidente Supermarket #32, via gift cards, for Village residents on government assistance, is hereby approved.

<u>Section 3.</u> <u>Implementation.</u> The Village Manager, Village Clerk, and the Village Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

<u>Section 4.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon its adoption.
