BACKGROUND AND ANALYSIS

Consistent with the Village's approved NBV100 Comprehensive Strategic Plan, the Kennedy Causeway Complete Street Project was conceived to create a complete street that better serves the Village's core. Under this project, the Village wishes to prioritize pedestrians' safety, have a more coherent multimodal network, and enhance local business success along its principal urban corridor.

The project would begin with short term improvements, which would include:

- Bicycle/Pedestrian Safety Improvements
- Intersections Improvements
- Relocation and Improvements of two (2) high traffic bus shelters

The Village applied to the Florida Department of Transportation County Incentive Grant Program (CIGP) 2020 Application Cycle to fund these improvements as shown in attachment "NBV Kennedy Causeway Complete Street Projects-Apps". The estimated cost for the design and construction of the short-term improvements is \$464,020.

FDOT approved the application with a 100% match requirement for the design and the construction phases and included the project in the Tentative Work Program for FYs 22-26 (See attachments NBV -Kennedy "Causeway Complete Street Project - Notice of CIGP Award" & "NBV- Kennedy Causeway Complete Streets Project -List on TWP FY 21-26"). The funding agency awarded \$25,000 for the design phase in FY 2023; the construction phase was awarded \$207,010 for FY 2025. Since the grants are reimbursable, NBV will fund \$50,000 by drawing from reserve funds and be reimbursed \$25,000 by the grant dollars. No matching funds have been determined as yet for the construction phase.

Currently, the Village contracted Stantec under their professional Service contract, RFQ 2019-005, to conduct a study to determine the feasibility of implementing the Complete Street Project. The investigation began in September 2021 and is approximately 40% complete. All project elements are on schedule to be completed by June 2022.

The commission is required to pass a resolution to accept the grant appropriation of \$25,000 and LAP Agreement (see attached "448629-1_SFGA_Package") from the Florida Department of Transportation for funding the design phase involving short-term improvements in the Kennedy Causeway Complete Street Project.

The Design Portion of the Kennedy Causeway Complete Streets Study Project (CP23-01) was originally budgeted in the 5 -Year Capital Plan for FY22-23, therefore a budget amendment (Exhibit B) will need to approved. \$50,000 will be allocated to CP23-01 in the Capital Projects Fund Account, Buildings - Lane Re-purposing (320.61.630.6206), with \$25,000 being transferred from the CITT Fund from the CITT Appropriated Fund Balance (Reserves) and \$25,000 in State Grant Revenues from the matching portion of the FDOT Grant.

\$25,000 of Appropriated Find Balance (115.00.389.3890) from the CITT Fund and \$25,000 of State Grant Revenue (320.00.334.3340) will be allocated for Capital Project CP23-01 Building -Lane Re-purposing (320.61.630.6206)
