- A. The purpose of this addendum is to provide clarification to the proposal. Several Sections and Articles have been modified:
- 1. Section 00010 Attachments Exhibit A Minimum Insurance requirements Section B
  - The Florida Department of Transportation shall be listed as an additional insured.
- 2. Article 10.4
  - The term cost of the Work means the sum of all direct costs necessarily incurred
    and paid by the CONTRACTOR in the proper performance of the Work. Except as
    otherwise may be agreed to writing by the VILLAGE, such costs shall be in
    amounts no higher than those prevailing Davis Bacon Wage Rate in Miami Dade
    County.
- 3. Section 00200- Instructions to Bidders Identical tie bids.
  - The following shall be deleted. 7.2 Identical ( tie bids): Shall be awarded by the Village, in the event of an identical tie Bid, preference shall be given to a business to responsive and qualified bidder with the most years in experience doing this types of work. Failure to provide proof of compliance when request shall be cause of rejection of the bid as determined by the Village.
  - Bidder shall abide by Section 000420 Award for Identical Tie Bids.
- 4. Article 17 Project Records
  - 17.1 The VILLAGE shall have right to inspect and copy during regular business hours at VILLAGE'S expense, the books and records and accounts of CONTRACTOR which relate in any way to the Project, and to any claim for additional compensation made by CONTRACTOR, and to conduct an audit of the financial and accounting records of CONTRACTOR which relate to the Project. CONTRACTOR shall retain and make available to VILLAGE all such books and records and accounts, financial or otherwise, which relate to the Project and to any claim for a period of three (3) five (5) years following final completion of the Project. During the Project and the three (3) five (5) year period following final completion of the Project, the CONTRACTOR shall provide the VILLAGE access to its books and records upon five (5) days written notice.
- 5. Section 01000 LAP Division 1 Specifications (Reve 3-11-21) (1-22) Section 4 (ALTERATIONS OF WORK) was inadvertently crossed out. Bidder will abide by this section of the ITB and Contract.
  - Section 4 (ALTERATIONS OF WORK) Section 4-3 is reinstated into the ITB.
