## **RESOLUTION NO. 2023-086**

A RESOLUTION OF THE MAYOR AND COMMISSION OF NORTH BAY VILLAGE, FLORIDA, APPROVING A FIRST AMENDMENT TO THE FAÇADE LICENSE AGREEMENT WITH SUNBEAM PROPERTIES INC. TO ALLOW THE VILLAGE TO INSTALL LIGHTING FOR THE HEART OF THE BAY MURAL ON THE GROVE BY THE BAY BUILDING LOCATED AT 1400 79<sup>TH</sup> STREET CAUSEWAY; PROVIDING FOR AUTHORIZATION; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on August 30, 2022, the North Bay Village (the "Village") Commission adopted Resolution 2022-068 authorizing the Village Manager to negotiate and execute a façade license agreement (the "License Agreement") with Sunbeam Properties Inc. ("Owner") to have a mural installed on the west-facing exterior wall of the Grove by the Bay building located at 1400 79th Street Causeway, North Bay Village, Florida (the "Building"); and

**WHEREAS**, on September 12, 2022, the Village and Owner entered into the License Agreement and the Village subsequently installed the "Heart of the Bay" mural at the Building (the "Mural"); and

**WHEREAS**, the Village desires to make the Mural visible at night by providing lighting for the Mural; and

**WHEREAS,** the Village and Owner have agreed to enter into a first amendment to the License Agreement, in substantially the form attached hereto as Exhibit "A", to allow the Village to uplight the Mural (the "First Amendment"); and

**WHEREAS**, the Village Commission desires to approve the First Amendment and authorize the Village Manager to execute the First Amendment with the Owner in substantially the form attached hereto as Exhibit "A"; and

**WHEREAS,** the Village Commission finds that this Resolution is in the best interest and welfare of the residents of the Village.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COMMISSION OF NORTH BAY VILLAGE, FLORIDA, AS FOLLOWS:

**Section 1.** Recitals. That each of the above-stated recitals are hereby adopted, confirmed, and incorporated herein.

**Section 2. Approval.** That the Village Commission hereby approves the First Amendment.

**Section 3. Authorization.** That the Village Commission hereby authorizes the Village Manager to execute the First Amendment with Owner, in substantially the form attached hereto as Exhibit "A," subject to the approval of the Village Attorney as to form, content, and legal sufficiency.

<u>Section 4.</u> Implementation. That the Village Manager is hereby authorized to take such action as may be necessary to implement the purpose and provisions of this Resolution and the First Amendment.

<u>Section 5.</u> <u>Effective Date.</u> That this Resolution shall be effective immediately upon adoption.
