RESOLUTION NO. 2024-061

A RESOLUTION OF THE MAYOR AND COMMISSION OF NORTH BAY VILLAGE, FLORIDA, AUTHORIZING THE VILLAGE MANAGER TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH B SIGN GROUP, INC. FOR THE FABRICATION AND INSTALLATION OF A FRAME SCULPTURE ON THE ISLAND WALK IN AN AMOUNT NOT TO EXCEED \$30,000,00: AMENDING THE BUDGET FOR FISCAL YEAR 2023-2024: **PROVIDING IMPLEMENTATION:** AND **PROVIDING FOR** AN EFFECTIVE DATE.

WHEREAS, North Bay Village (the "Village") wishes to increase public art installations throughout the Village and, towards that end, install a public art project along the Island Walk portion of the property located at 8000 West Drive (the "Project"); and

WHEREAS, B Sign Group, Inc. (the "Artist") has proposed to design, fabricate, and install a photo archway for the Project (the "Services") as set forth in the proposal attached hereto as Exhibit "A" (the "Proposal"); and

WHEREAS, Section 36.25(L) of the Village Code provides that the Village Commission may award a contract without sealed bidding upon a finding that the process of competitive bidding and competitive proposals is not in the best interest of the Village; and

WHEREAS, due to the artistic and specialized nature of the Services offered by the Artist, Village staff recommends that the Village waive competitive bidding as it is not in the best interest of the Village to competitively bid the Services and approve the Proposal; and

WHEREAS, pursuant to Section 36.25(L) of the Village Code, the Village Commission desires to authorize the Village Manager to negotiate and execute an agreement with the Artist in an amount not to exceed \$30.000 (inclusive of a \$4,100 contingency), consistent with the Proposal and subject to approval by the Village Attorney as to form, content, and legal sufficiency; and

WHEREAS, on September 28, 2023, the Village Commission adopted Resolution No. 2023-109 approving the budget for fiscal year 2023-2024 (the "Budget"); and

WHEREAS, pursuant to Section 166.241, Florida Statutes, the Village

Commission may amend a budget at any time within a fiscal year; and

WHEREAS, in order to provide the necessary funding for the Services and pursuant to Section 35.21 of the Village Code of Ordinances and Florida Law, the Village Commission desires to amend the Budget consistent with the staff memorandum accompanying this resolution by authorizing the line-item transfers as further provided in Exhibit "B" attached hereto and incorporated herein; and

WHEREAS, the Village Commission finds that this Resolution is in the best interest and welfare of the residents of the Village.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COMMISSION OF NORTH BAY VILLAGE, FLORIDA, AS FOLLOWS:

Section 1. Recitals. That each of the above-stated recitals are hereby adopted, confirmed, and incorporated herein.

<u>Section 2.</u> <u>Authorization.</u> Pursuant to Section 36.25(L) of the Village Code, the Village Commission hereby authorizes the Village Manager to negotiate and execute an agreement with the Artist for the Services in an amount not to exceed \$30.000 (inclusive of a \$4,100 contingency), consistent with the Proposal and subject to approval by the Village Attorney as to form and legal sufficiency.

Section 3. Amending Budget. That the Village Commission hereby approves an amendment to the budget by authorizing the line-item transfers as further provided in Exhibit "B" attached hereto and incorporated herein.

Section 4. Implementation. That the Village Manager and Village Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> That this Resolution shall be effective immediately upon adoption.






