### **Summary of Proposed Ordinance and Statement of Public Purpose to be Served**

AN ORDINANCE OF THE MAYOR AND COMMISSION OF NORTH BAY VILLAGE, FLORIDA, AMENDING THE VILLAGE CODE OF ORDINANCES BY CREATING SECTION 10.17, "ADVERTISEMENT AND NOTICE BY PUBLICATION ON A PUBLICLY ACCESSIBLE WEBSITE," TO ALLOW FOR THE PUBLICATION OF LEGALLY REQUIRED ADVERTISEMENTS AND NOTICES ON A PUBLICLY ACCESSIBLE WEBSITE AS PERMITTED BY CHAPTER 50, FLORIDA STATUTES, AS MAY BE AMENDED; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; PROVIDING FOR CONFLICTS; AND PROVIDING FOR AN EFFECTIVE DATE.

The purpose of this ordinance is to amend the Village Code and the Unified Land Development Code (ULDC) to permit the publication of legal notices on the publicly accessible website designated by Miami-Dade County, in accordance with Chapter 50 of the Florida Statutes.
