A RESOLUTION OF THE MAYOR AND COMMISSION OF NORTH BAY VILLAGE, FLORIDA, AUTHORIZING THE OF WORK ORDER ISSUANCE TO CONSULTING, INC. PROVIDE CONSTRUCTION TO **ENGINEERING AND INSPECTION (CEI) SERVICES FOR** THE **TREASURE ISLAND ADA SIDEWALK** IMPROVEMENT PROJECT IN AN AMOUNT NOT TO **EXCEED \$38,606; AMENDING THE BUDGET FOR FISCAL** YEAR 2022-23; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, North Bay Village ("Village") desires to implement Phase 2 of the Treasure Island ADA Sidewalk Improvements Project (the "Project"); and

WHEREAS, the Village issued Request for Qualifications No. 2019-005 (the "RFQ") for continuing professional engineering services; and

WHEREAS, pursuant to the RFQ, the Village Commission selected EAC Consulting, Inc. (the "Consultant") as one of the consultants to provide the Services and authorized the Village Manager to execute an agreement with Consultant (the "Agreement"); and

WHEREAS, BCC Engineering, LLC has provided the Village with design services for the Project; and

WHEREAS, in order to ensure construction of the Project is done in accordance with the Project design documents, the Village requires construction engineering and inspection (CEI) services (the "Services") for the Project; and

WHEREAS, Consultant has provided a proposal to perform the Services for the Project; and

WHEREAS, the Village Commission desires to authorize the Village Manager to issue the work order attached hereto as Exhibit "A" for the Project in an amount not to exceed \$38,606, consistent with the Agreement previously entered into between the Village and Consultant; and

WHEREAS, on September 29, 2022, the Village Commission adopted Resolution No. 2022-79 approving the budget for fiscal year 2022-2023 (the "Budget"); and

WHEREAS, pursuant to Section 166.241(5), Florida Statutes, the Village Commission may amend a budget at any time within a fiscal year; and

WHEREAS, pursuant to Section 35.21 of the Village Code of Ordinances and Florida Law, the Village Commission desires to amend the Budget consistent with the staff memorandum accompanying this resolution by authorizing the line item transfers as further provided in Exhibit "B" attached hereto and incorporated herein; and

WHEREAS, the Village Commission finds that this Resolution is in the best interest and welfare of the residents of the Village.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COMMISSION OF NORTH BAY VILLAGE, FLORIDA, AS FOLLOWS:

Section 1. Recitals. That each of the above-stated recitals are hereby adopted, confirmed, and incorporated herein.

<u>Section 2.</u> Authorization. That the Village Commission hereby authorizes the Village Manager to issue the work order attached hereto as Exhibit "A" in an amount not to exceed \$38,606, consistent with the Agreement previously executed.

<u>Section 3.</u> <u>Amending Budget.</u> That the Village Commission hereby approves an amendment to the budget by authorizing the line item transfers as further provided in Exhibit "B" attached hereto and incorporated herein.

<u>Section 4.</u> Implementation. That the Village Manager and the Village Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> That this Resolution shall be effective immediately upon adoption.

PROFESSIONAL SERVICES

This Work Order between North Bay Village, a Florida municipal corporation ("VILLAGE"), and <u>EAC Consulting, Inc.</u> authorized to transact business in Florida ("CONSULTANT"), is pursuant to the General Professional Engineering and Architectural Services Agreement dated November 18, 2019 and expiring on November 18, 2022.

PROJECT DESCRIPTION

EAC Consulting, Inc (EAC) shall perform professional Engineering Services for the "Treasure Island ADA Improvements" project.

The Village is a thriving waterfront community situated between the cities of Miami and Miami Beach in the middle of Biscayne Bay.

The Village is requesting to perform professional services to assist the Village with Treasure Island ADA Improvements project. The construction work will be done under the Invitation to Bid (ITB) #2022-006, FM# 444197-1-58-01.

The construction project includes Type F Curb and Gutter, Type D Curb, proposed curb ramps, proposed concrete sidewalk, proposed detectable warnings, existing concrete sidewalk to be removed and replaced, existing driveway to be removed/replaced by others, and upgrades to 4 intersections along JFK Causeway at Adventure Avenue, Hispanola Avenue, 1800 Block, and East Treasure Drive to modify existing Accessible Pedestrian Signals (APS) and install additional APS on the minor street, as shown in the set of signed and sealed Contract Plans (dated June 22, 2022) prepared by BCC Engineering, LLC.

The estimated construction cost is \$114,738.21, and the estimated construction time is nine (9) months or approximately 270 calendar days as advised by the Village's Project Manager (PM).

GENERAL REQUIREMENTS

Quality Control

The CONSULTANT is responsible for the quality control (QC) of their work and of its sub-consultants. The CONSULTANT shall provide to the VILLAGE the list of sub-consultants which shall be used for this project. This list shall not be changed without prior approval of the VILLAGE. All sub-consultant documents and submittals shall be submitted directly to the CONSULTANT for their independent QC review. The VILLAGE shall only accept submittals for review and action from the CONSULTANT.

EAC's Construction Engineering & Inspection (CEI) Quality Management Plan (QMP) Program, which we enforce on our sub-consultants, includes:

- Quality Staffing Highly experienced personnel ensuring an excellent match between the task and staff.
- Quality Management Proper Quality Management of a project incorporates Quality Assurance (QA)/Quality Control (QC) and is essential for achieving the required product quality.
- Quality Control Quality Control consists of checking on our deliverables, project documentation, field inspection, and sampling and testing.
- Quality Assurance Quality Assurance monitors and assesses the Quality Control process. Our Quality Assurance leader Andrew Pierce, PE or his designee will be assigned to this project to review procedures and the products these processes yield. QA/QC Reviews will not exceed a six-month interval.

SPECIFIC SCOPE OF SERVICES

The Scope of Services to be provided by CONSULTANT shall be as follows:

The work will require the presence of one part-time Project Manager (PM) and part-time CEI Inspector (I). Refer to Tasks 1 and 2 below.

EAC will follow the contract documents, including the 2021-2022 FDOT Standard Plans and the January 2021 FDOT Specifications listed on the plans, the project's Specification Package, the Miami-Dade County Public Works Manual, the 2009 MUTCD, and perform the following scope:

<u>Task 1 – Part-Time Project Manager (PM)</u>

The part-time PM will manage and administrate the CEI Inspector and the inspections.

Task 2 – Part-Time CEI Inspector (I)

• The part-time CEI Inspector will inspect the removal, installation and quantify the construction elements per the contract documents, curbs, sidewalks, driveways, detectable warnings, APS modifications and new APS; will prepare and submit daily construction reports to the Village Project Manager and coordinate as required; will review monthly payment application quantities; and will enforce the Contractor with the requirements of the Stormwater Pollution Protection Plan, Plan Sheet 5; and will generate the punchlist and perform the final inspection.

Per the Village, Part-Time CEI Resident Compliance Specialist (RCS) will not be required. FDOT, the funding agency will review contractors' contract and will approve based on Federal rules compliance qualification. No additional services will be required once contract is awarded.

Per the Village, laboratory testing will be carried out by the contractor and results submitted to the Village. The Inspector will be required to assist the Village in review and approval of testing results.

This proposal does not include a CEI Project Administrator (PA), RCS, and laboratory testing services. An additional work order will be required if the Village requires these services.

If authorized in writing by the VILLAGE, as an amendment to this Task Order, the CONSULTANT shall furnish, or obtain, Additional Services of the types listed in the MASTER AGREEMENT. The VILLAGE, as indicated in the MASTER AGREEMENT, will pay for these services.

PERFORMANCE SCHEDULE

The CONSULTANT shall perform the services identified in Task 1 within 9 months of the written Notice to Proceed.

PROJECT FUNDING

Performance of this project is at the VILLAGE's discretion and may be contingent upon the VILLAGE receiving funding and work shall not begin until the VILLAGE provides a Notice to Proceed to CONSULTANT.

METHOD OF COMPENSATION

The services performed will be accomplished using the Not-to-Exceed method of compensation. The total hourly rates payable by the VILLAGE for each of CONSULTANT's employee categories, reimbursable expenses, if any, and sub-consultant fees, if any, are shown on **Exhibit A** attached hereto and made a part hereof. Pay application requests shall be prepared on the VILLAGE's approved pay application request form. The CONSULTANT shall submit the pay application request to the VILLAGE's Project Manager for review and approval. Please copy the PW department's administrative assistant at pwdocument@nbvillage.com on all payment correspondences. Pay application requests shall be submitted monthly.
