SUBJECT: A Resolution Authorizing a Budget Amendment in the Amount of \$50,000 for Sanitation Truck Repairs - Village Manager Ralph Rosado, PhD, AICP (Public Works Director Marlon Lobban)

RECOMMENDATION

A RESOLUTION OF THE MAYOR AND COMMISSION OF NORTH BAY VILLAGE, FLORIDA, AMENDING THE BUDGET FOR FISCAL YEAR 2023-2024 TO PROVIDE FOR SANITATION VEHICLE EXPENSES; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.

It is recommended that the Village Commission approve a budget amendment in the amount of \$50,000 to cover current and future repairs needed to maintain sanitation trucks to provide solid waste pickup services.

BACKGROUND AND ANALYSIS

The proposed resolution seeks the Village Commission's consideration to approve additional funding to cover maintenance and repairs for sanitation trucks.

The approved Fiscal Year 2024 budget allocation for sanitation truck repairs has been fully utilized due to repeated maintenance needs. Currently, there's an outstanding invoice from Nextran Truck Center for hydraulic repairs. The Operations Division anticipates further maintenance for the remainder of the fiscal year.

To ensure uninterrupted solid waste services, staff proposes a budget amendment of \$50,000 specifically allocated for sanitation truck maintenance and repairs. This additional funding will cover the anticipated costs and guarantee the continued efficiency of waste management

operations.

A RESOLUTION OF THE MAYOR AND COMMISSION OF NORTH BAY VILLAGE, FLORIDA, AMENDING THE BUDGET FOR FISCAL YEAR 2023-2024 TO PROVIDE FOR SANITATION VEHICLE EXPENSES; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on September 28, 2023, the North Bay Village (the "Village") Commission adopted Resolution No. 2023-109 approving the budget for fiscal year 2023-2024 (the "Budget"); and

WHEREAS, pursuant to Section 166.241, Florida Statutes, the Village Commission may amend a budget at any time within a fiscal year; and

WHEREAS, pursuant to Section 35.21 of the Village Code of Ordinances and Florida Law, the Village Commission desires to amend the Budget consistent with the staff memorandum accompanying this resolution by authorizing the line item transfers as further provided in Exhibit "A" attached hereto and incorporated herein; and

WHEREAS, the Village Commission finds that this Resolution is in the best interest and welfare of the residents of the Village.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COMMISSION OF NORTH BAY VILLAGE, FLORIDA, AS FOLLOWS:

Section 1. Recitals. That each of the above-stated recitals are hereby adopted, confirmed, and incorporated herein.

Section 2. <u>Amending Budget.</u> That the Village Commission hereby approves an amendment to the budget by authorizing the line item transfers as further provided in Exhibit "A" attached hereto and incorporated herein.

<u>Section 3.</u> <u>Implementation.</u> That the Village Manager, Village Clerk, and Village Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

Section 4. Effective Date. That this Resolution shall be effective immediately upon adoption.
